Subject: ADVENTUROUS CORRUPTION OF DHS, GNCT OF DELHI

(DHS done Limited Tender for Rs. 3 Crores and will open in 5 Days & 17 Hours)

I have already exposed multiple cases of Corruption of H & FW Deptt, GNCT of Delhi as Whistle Blower and again hereby exposing another corruption of DHS as Whistle Blower which is the result of increase courage to do corruption for NO ACTION in previous corruption cases.

Central Procurement Agency (CPA) of DHS, nodal agency for procurement of all items required by health facilities under GNCTD invites bids from interested bidders through e-procurement web site of Govt. of NCT of Delhi for **“Procurement of Miscellaneous Items for H1N1 Management”**. CPA mentioned in the Tender that **“This is a limited tender enquiry”**.

HIGHLIGHTS OF THIS TENDER

1. This is a Limited Tender Enquiry.
2. Tender Value is for Rs. Three Crores.
3. Bid Submission Start Date is 15-10-2015 at 06:00 PM **AND** Bid Submission End Date is 21-10-2015 at 11:00 AM.

OBJECTIONS IN THIS TENDER:

1. **DHS has done Limited Tender for Rs. Three Crores.** However it could not be more than Rs. 25 Lacs – There is VIOLATION OF GENERAL FINANCE RULE (GFR) 150 (i) and 151 (i).
2. **DHS will open the Tender within 5 Days and 17 Hours from the date of start of Bid Submission.** However, the minimum time to be allowed for submission of bids should be **three weeks** from the date of publication of the tender notice - There is VIOLATION OF GENERAL FINANCE RULE (GFR) 150 (v); 151 (iii) and 160 (v).

NO EXIGENCIES IN THIS TENDER WHICH NEEDS VIOLATION OF GFR

1. **The essential items for H1N1 Management are – PPE Kit, N-95 Masks, Viral Transport Medium (VTM), Hand scrub, Ventilators, Oseltamivir Tabs & Syp., Vaccines.** This tender is not done for these items and therefore exigencies not proved here.
2. **Tender is done for Miscellaneous items for H1N1 Management i.e. Tissue Papers, Soap, Dustbins, Canopy and Address System Battery Operated.** DHS going to purchase Canopy and Address System Battery Operated first time for Advertisement. Tissue Papers, Soap and Dustbins are routine items for Dispensaries and Hospitals which are not specialized items for H1N1 Management. Purchasing these items is not an emergency. Therefore exigencies not proved here and violation the GFR is not required here. Patients of H1N1 can be managed without these items

and already managed without these items in previous years.

3. I'm not aware, whether DHS has taken prior approval for this kind of tender from the competent authorities of H & FW Deptt, Finance department and other authorities of Delhi Govt. Therefore, it is a matter of enquiry also. If it is not done, it again become more serious issue.

WHY THIS TENDER IS CALLED ADVENTUROUS CORRUPTION OF DHS?

1. I have filed 3 complaints against Corruption of DHS. NO ACTION in any complaint is increasing courage of authorities of DHS. Complaints are as follows:
(A) Govt. Revenue Loss due to Unnecessary Tendering by DHS GNCTD dated 12-03-2015.
(B) Tendering Fraud AND Deception to Tenderers & Government by DHS, GNCT of Delhi dated 05-09-2015
(C) Corruption in DGEHS Tender Through Gross Violation of Finance Rules.
2. Dr. Vijoy Kumar, CMO, CPA is also well aware with this fact that Limited tender should not be more than Rs. 25 Lacs. Violation of GFR with knowing all the facts is the result of increase courage for NO ACTION in Corruption cases. (Download the copy of email of Dr. Vijoy in which he himself stated that Limited tender is for Rs. 25 Lacs and more in exigencies). **Risk taking capacity of Authorities of DHS is increasing day by day and they boldly violating GFR even knowing the rules. It means Rules, Regulations and Indian Law is nothing for these people. They are also fully confident that no one in India can take action against them specially in Corruption Cases.**
3. **Why Authorities are daring to do corruption and NO ACTION in corruption cases of H & FW Deptt.?** It is Because of Sh. S.C.L. Das, Secretary to Hon'ble Lt. Governor only who has started corruption in H & FW Deptt when he was Secretary of H & FW Deptt and now he is Secretary to Hon'ble Lt. Governor. This is also boosting morale of other Authorities of H & FW Deptt to do corruption without hesitation. They know very well that Sh. S.C.L. Das will protect them against any action for Corruption charges.
4. If I'm wrong about Sh. S.C.L. Das then please let me know, Why Sh. S.C.L. Das not ordering Anti Corruption Branch (ACB) to probe in exposed corruption cases in time bound manner in all my complaints.

PRAYER:

Sir, **It is a SCANDAL of Rupees 3 Crore of Public Money and it must be stopped.** Please stop wastage of Public Money of Rupees 3 Crore. I request you to please take necessary action as per law against the officers/officials of DHS to check further more corruption in H & FW Deptt. I also requested to take necessary action against Sh. S.C.L. Das because Enquiry & Action is only possible after dismissal of Sh. S.C.L. Das from his services because he is sitting at a very key post as Pr. Secretary to Hon'ble Lt. Governor from where he is managing whole corruption and protecting Corrupts.
