I'm Dr. Avinash Kumar, posted in Babu Jagjivan Memorial Hospital (BJRM), Jahangirpuri, Delhi-110033, since 11-12-2013 to till date as Specialist Grade-II, Medicine. Before that I was posted in Aruna Asaf Ali Govt. Hospital (AAAGH), 5-Rajpur Road, Delhi-110054 since 21-09-2004.

I have exposed huge corruption of AAAGH to Central Vigilance Commission (CVC) on 01-08-2013 as "WHISTLE BLOWER" but my identity of WHISTLE BLOWER was exposed by CVC itself, M.S. AAAGH, Dr. Ashok Jiaswal and Sh. S.C.L. Das, Pr. Secretary Health, Delhi.

Knowing the fact, Sh. S.C.L. Das who is the KINGPIN of Corruption of AAAGH and given protection to all the alleged doctors started harassment and victimization of undersigned i.e. Dr. Avinash Kumar, Whistle blower. He has not taken any action against the Delinquent doctors of AAAGH till date but continuing harassment and victimization of Dr. Avinash Kumar, Whistle blower.

I have mailed several representations against Corruption of Sh. S.C.L. Das, Pr. Secretary Health AND AAAGH to Hon'ble President of India, Hon'ble Prime Minister of India, many secretaries of Various departments of India, DOPT, Home Affairs, CVC, CBI, Hon'ble Lt. Governor of Delhi, Chief Secretary of Delhi, National Human Right Commission along with many other authorities of Delhi Govt and India.
