Secondly we would like to have the chemical analysis report of the two bathces supplied to our hospital. this may be keep it as a earliest as the matter is under inquiry

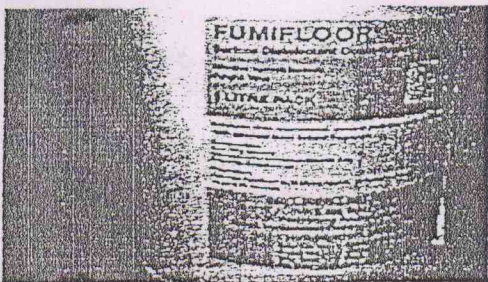
