SUBJECT: Attempt of Sh. S.CL. Das, Pr. secy. health, Govt of NCT of Delhi to protect Corrupt Doctors of Aruna Asaf Ali Govt. Hospital, Delhi-54

Respected Sir,

In continuation to my previous mails dated 31-08-2014 on **Subject: Harassment of Whistle Blower by Secy. Health, Mr. S.C.L. Das, Govt. of NCT of Delhi**, with due respect It is further to state that **Sh. S.CL. Das, Pr. secy. health, Govt of NCT of Delhi has taken another step to protect the corrupt doctors of AAAGH and proved himself that he is always with the corrupt doctors and he will help & save them till the end.**

“In reference to ORDER no. F.32/C-328/2013/H&FW/909 Dated 03-11-2014 issued by Dy. Secretary (Vigilance) H & FW Deptt. which is as follows:

The Secretary (H & FW) has constituted a committee of following officers to enquire into the allegations of corruption against Dr. Surendra Singh, Dr. S.B. Srivastava and Dr. Ashok Jaiswal in Aruna Asaf Ali Govt. Hospital, Delhi.

The committee will inquire into various allegations leveled in numerous complaints filed by Kranti Kari Subhash Manch regarding financial and administrative irregularities in AAAG hospital and will submit its report within two weeks time positively. The report inter alia must include the act of omission and commission of the delinquent officers/officials, if any.”

Here it is important to state that a 5 member committee of AAAGH had enquired the corruption cases of AAAGH from Oct 2013 to 08-05-14 the same cases alleged by Kranti Kari Subhash Manch. This report was submitted by the M.S., AAAGH to Sh. S.C.L. Das on 08-05-14 IN L.G. office which was forwarded to Directorate of Vigilance (DOV). ON dated 07-07-14, DOV (with prior approval of Chief Secretary CS/CVO) directed Pr. Secy H & FW Deptt to file formal

complaint in ACB and file Charge sheet against Dr. S.B. Srivastava, Dr. Surindra Singh and Dr. Ashok Jaiswal of AAAGH. Pr. Secy. Health forwarded this letter **on dated 17-07-14** to M.S. AAAGH for the same. M.S., AAAGH has filed complaint in ACB **on 23-07-14 with diary no. 7662**. FIR is still pending against this case.

Therefore, my leading questions are as follows against this ORDER:

1. What was that enquiry which was held in AAAGH through 5 members committee in the month of Oct 2013 and completed on 08-05-2014?
2. Which enquiry report the M.S., AAAGH has submitted in LG Officer to Pr. Secretary Health, Sh S.C.L. Das on 08-05-2014 for necessary action?
3. M.S. AAAGH has filed complaint in ACB on 23-07-14 through diary no 7662 on the direction of Pr. Secy. Health, Sh S.C.L. Das which was forwarded from DOV against Dr. S.B. Srivastava, Dr. Surindra Singh and Dr. Ashok Jaiswal of AAAGH? **Was it a joke?**
4. Why new committee of juniors are formed for the same case in which only FIR is pending?

IMPORTANT: This is a 4 member committee in which 3 members of the committee are more JUNIOR to all the alleged 3 doctors.

How Junior Committee Members can enquire against Senior doctors i.e. Dr. S.B. Srivastava (SAG), Dr. Surindra Singh (CMO NFSG) and Dr. Ashok Jaiswal (SAG) Level doctors?

1. One FIR was filed in Harihar, Karnataka against M/s Shashi Medical Services and 2nd FIR no – 473 dated 31-10-14 also filed in Civil Lines Police Station against M/s Shashi Medical Services in one alleged case regarding supply of FUMI FLOOR SOLUTION in AAAGH. Is it not a substance of Enquiry? **Why Sh. S.CL. Das has constituted a new committee of Junior members to do enquiry against Senior Doctors of SAG Cadre in the same case?**
2. It is a inter-state and inter-hospital corruption case. Karnataka and Delhi state is involved and there may be chance that the firm had supplied the spurious solution to other state also. Then **Why Sh. S.CL. Das has not recommended for CBI Enquiry or enquiry from any independent agency?**
3. Enquiry committee has recommended to do deep enquiry through any independent agency. Then Why Sh. S.CL. Das has constituted a new committee of Junior members to do enquiry against Senior Doctors of SAG Cadre in the same case?

4. How Sh. S.CL. Das can bypass the order of Chief Secretary / CVO appointed by Central Vigilance Commission (CVC) who has given approval to file case against Dr. S.B. Srivastava, Dr. Surindra Singh and Dr. Ashok Jaiswal of AAAGH?

This above said ORDER issued from H & FW Deptt is definitely an attempt of Sh. S.CL. Das to protect the Corrupt doctors of AAAGH. He is therefore ignoring all the rules, Regulations and Law of India and proving himself that he is also hands in gloves with the corrupt doctors of AAAGH.

THEREFORE, I HUMBLY REQUEST YOU SIR TO PLEASE CONDUCT CBI ENQUIRY IN CORRUPTION CASES OF AAAGH WHICH ARE DEEPLY ROOTED. I eagerly waiting for your kind reply.
