It is the complaint against Authorities of H&FW Deptt, GNCTD who had continuously protected and still protecting **Certified Corrupts of AAAGH** and denied submission of Charge Sheet to Directorate of Vigilance (DOV), GNCTD despite Multiple Reminders from DOV, GNCTD.

## WHAT IS THE CASE?

As I have exposed multiple corruption cases of AAAGH as Whistle blower under “**PUBLIC INTEREST DISCLOSURE & PROTECTION OF INFORMATION RESOLUTION**” to CVC on 01-08-2013 (**CVC Complaint No. 4726/13/10**).

A **5 member committee** enquired the said complaints, fixed responsibilities against several doctors and submitted the enquiry report to Secretary, H&FW on **08-05-2014**. **Due to intervention of Hon'ble Lt. Governor**, Dr. Ashok Jaiswal and Dr. Surender Singh were transferred from AAAGH to BSA Hospital, Rohini and Bhagwan Mahavir hospital, Pitampura respectively on **09-05-2014**. **It was a corruption of around Rs. 3 Crores in AAAGH and the corrupts destroyed concerned file of purchasing Rs. 1.5 crores.**

After going through the 5 member enquiry report, **Chief Secretary, GNCTD ordered Secretary, H&FW Deptt on dated 07-07-2014 for D/P against Dr. Ashok Jaiswal, Dr. Surender Singh and Dr. S.B. Srivastava and directed to file complaint in ACB and draft charge sheet against these SPS.** Dr. S.K. Sharma, M.S., AAAGH, has filed the case in ACB on 23-07-2014 through Diary no.7662 and 7663.

Dr. S.B. Srivastava was suspended by H&FW Deptt on the date of retirement i.e. 30-06-2016 after my multiple letters/complaints. **Here again H&FW Deptt has protected Dr. Ashok Jaiswal and Dr. Surender Singh and no departmental action is taken till date.**

NO action against the certified corrupts forced me to file RTI in H&FW Deptt, DOV, Office of Chief Secretary and AAAGH revealed the shocking information. The provided documents against RTI is clearly indicating that there is a **Gang of Corrupt Authorities are in existence in H& FW Deptt who was and is protecting the Certified Corrupts of AAAGH.**

In 2014, Sh. S.C.L. Das (Secretary, H&FW Deptt), Sh. S.B. Shashank (Sp. Secretary, Vigilance (H&FW)), Mrs. Sushma Singh (Dy. Secretary H&FW) were the authorities posted in H&FW Deptt. Latter on, after transfer of Secretary and Sp. Secretary, charge taken by Mrs. Madhu K. Garg (Sp. Secretary, Vigilance (H&FW)), Sh. Tarun Seem (Secretary H&FW) and Sh. Akash Mohapatra (Sp. Secretary, Vigilance (H&FW) who stayed in H&FW Deptt and they all are responsible for dumping the complaints and all correspondences to take action against the certified corrupts of AAAGH.

The shocking information received under RTI is that Dr. S.K. Sharma, M.S, AAAGH has also submitted Draft Charge Sheet along with all the copies of all the 11 cases to Mrs. Sushma Singh, Dy. Secretary, Vigilance (H&FW) on dated 09-09-2014.

DOV is continuously sending letters to Secretary, H&FW Deptt, GNCTD to supply the documents to DOV for "Initiation of D/P against doctors of Aruna Asaf Ali Govt. Hospital" BUT the competent Authorities of H&FW denied DOV.

PIO, H&FW Deptt denied to provide information under Section8(1)(h) of the RTI Act, 2005. **Chor ki Dadhi main Tinka.** Therefore H&FW Deptt denied information.

**There are only three possibilities for denied documents to DOV by H&FW Deptt:**

1. The **authorities of H&FW are illiterate** and don't know the Office/Vigilance Procedures and therefore to hide their illiterate personality, they are not sending the documents to DOV.
2. The authorities of H&FW Deptt are **NIKAMME KAMCHOR HAIN** and therefore they are not sending the documents to DOV. **Sarkar se Muft ki Salary le rahe hain.**
3. The authorities of H&FW Deptt had/have fixed Monthly installment (**Milking Money**) from the corrupts of AAAGH and therefore they are not sending the documents to DOV.

Apart from the above three reasons, I don't think any other possibility or cause of protection to Corrupts by H&FW Deptt since 09-09-2014.

**PRAYER:**

Respected Sir, I request not only to take Legal and Departmental action against **Dr. Ashok Jaiswal, Dr. Surender Singh and Dr. S.B. Srivastava**, the Corrupts of AAAGH but simultaneously take Legal and Departmental action against **Sh. S.C.L. Das, Sh. Tarun Seem, Sh. S.B. Shashank, Smt. Madhu K. Garg, Sh. Akash Mohapatra and Smt. Sushma Singh**, the authorities of H&FW Deptt also. It is further requesting to conduct CBI enquiry against the said authorities of H&FW Deptt to explore widely the status of other Corruption cases of H&FW Deptt.

CBI Enquiry of H&FW Deptt is also essential to identify the extent of Network of corruption and to prevent innocent Officers/officials of H&FW Deptt who are trapped in the grip of these corrupts and the authorities of H&FW Deptt are doing harassment of innocent Officers/officials for extortion of Money.
