Subject: Harassment for Exposing Corruption of Aruna Asaf Ali Govt. Hospital (AAAGH), 5-Rajpur Road, Delhi-54 and Request for Justice

Respected Sir,

I Dr. Avinash Kumar wish to say that I have served my duties to Aruna Asaf Ali Govt. Hospital since 2004 as Non-Teaching Specialist, Medicine with full enthusiasm, punctuality, high morality, maintaining the ethical values and faith of the competent authorities and all the employees of this hospital.

As per the official order issued from the Hospital dated 28/09/2006, I have provided my health care services as official Physician to the Hon'ble Lt. Governor of Delhi as and when required. I provided full emergency coverage to Raj Niwas during any gathering in Raj Niwas apart from my assigned hospital duties since 2006. I also provided my best health care services on priority to the officials, staff members, employees and security personnel of Raj Niwas.

Sir, when I came across with several corrupt practices and incidents particularly in the matter of purchase of Sanitation items like Fumy Floor, multiple cleaning solutions and other similar related items. I learnt about other serious irregularities in the matter of purchase of store items done especially by **Dr. Surendra Singh**, CMO NFSG in co-operation with **Dr. Amit Sharma**, Incharge General store and being an upright, honest and dedicated government servant brought in the knowledge of Medical Superintendent **Dr. S.B. Srivastava** and **Dr. Ashok Jaiswal** also but none of them had taken any necessary action in public interest but continuously they co-operated Dr. Surendra Singh's corrupt practices.

Considering it to be my moral duty, I raised my voice against the corruption as '**WHISTLE BLOWER**' and addressed a letter dated 01-08-2013 to Central Vigilance Commission (CVC) under "**PUBLIC INTEREST DISCLOSURE & PROTECTION OF INFORMATION RESOLUTION**" in which I exposed several cases of corruption held in AAAGH by the nexus of doctors by using expert unethical practices through violation of Govt. Finance Rules.

In response to the said letter dated 01-08-2013, the Central Vigilance Commission addressed a confidential letter dated 13-08-2013 to me requiring confirmation about the complaint dated 01-08-2013. However, surprisingly, the said letter was not directly handed over to me and

The Medical Superintendent, Dr. Ashok Jaiswal had opened the letter of CVC dated 13-08-2013 upon which the endorsement was made by the M.S. to send the letter to vigilance officer and then another endorsement by the Vigilance officer, Dr. Amit Sharma. This way M.S., Dr. Ashok Jaiswal had disclosed my identity in the hospital. Furthermore, he also started negative canvassing to other doctors and employees of the hospital.

I then submitted my confirmation and grievances to CVC through another letter dated 28-08-2013 provided the details about disclosure of my Identity by the Medical Superintendent, Aruna Asaf Ali Govt. Hospital to Dr. Surendra Singh, Dr. Amit Sharma who are the main culprits of corruption.

The aforesaid correspondence was registered by the CVC under "PUBLIC INTEREST DISCLOSURE & PROTECTION OF INFORMATION RESOLUTION" vide complaint no. 4726/13/10 and sent the intimation through letter dated 26-09-2013 which was again opened by Dr. Ashok Jaiswal and same endorsement done and marked to the Vigilance officer, Dr. Amit Sharma.

Afterward, all the above mentioned doctors including the Medical Superintendent had started negative canvassing against me in the hospital as well as to higher authorities of Health & Family Welfare department in Delhi Secretariat.

The result of negative canvassing brought in form of my transfer from this hospital to Babu Jagjiwan Ram Memorial Hospital, Jahangirpuri, Delhi through letter dated 28-11-2013 with stand relieved order w.e.f. 03-12-2013 (A/N). (Page 59)

In fact, I am not clear about the main cause behind this transfer order but this transfer order is not Justifiable from any angle because of following reasons:

1. In my opinion, this **transfer order is not a routine transfer** because it providing an impression of mutual transfer. Dr. Javed Salam from Babu Jagjiwan Ram Memorial hospital transferred to Aruna Asaf Ali Govt Hospital and Dr. Avinash Kumar transferred from AAAGH to BJRM Hospital. Apart from these two names, none of other doctor is transferred from any hospital.
2. In fact, this **transfer order issued is not a mutual transfer** because I Dr. Avinash Kumar has not submitted any transfer request.
3. This **transfer is done when MODEL CODE OF CONDUCT is enforced in Delhi** in view of Assembly elections. Reason of transfer during MODEL CODE OF CONDUCT enforcement is not mentioned in transfer order and therefore can not be in public interest.
