SUBJECT: Manipulation and Fabrication of Transfer Records of Doctors done by Sh. S.CL. Das, Pr. secy. health, GNCT Delhi after exposure of misconduct

Respected Sir,

In continuation to my complaint dated 08-12-2014 regarding **Misuse of Power by Sh. S.C.L. Das, Pr. Secy. Health, Govt of NCT of Delhi in Transfer Postings of Doctors, Sh. S.C.L. Das has started manipulation and Fabrication of of transfer records after filing the complaint and exposure of misconduct, a serious issue.** In the letter dated 08-12-2014, I have raised following issues and alleged that **Sh. S.C.L. Das has misused his power in Transfer posting of doctors:**

1. **Sh. S.C.L. Das has kicked out his own order issued by OSD (H & FW) through order no. F. (3)/osdpshfw/2011/MIS_Review/HFW/443-49 DATED 20-05-2014 with prior approval of Secretary (H&FW) regarding Transfers that “ All orders of transfer of Doctors, Nurses, Technicians, Para-medical staff and all other personnel shall be done only through MIS, by the concerned section/officer. Such transfers which are done manually will henceforth be treated as inoperative and only MIS generated transfer orders shall be treated as valid”.**

2. **Sh S.C.L. Das has also kicked his own framed Transfer Policy** dated 22-08-2014 and Transfers done through su-moto power and not done as per transfer policy.

3. Sh. S.C.L. Das **transferred 19 newly recruited doctors** through UPSC, joined Delhi Govt. in September 2014, through order no. F.70.43.2014/H&FW/part-file/12356-80 dated 07-11-2014 **without publishing transfer order on the website.**

4. Sh. S.C.L. Das transferred one doctor from AAAGH to DHAS through order no.F.70/57/03/H&FW/PF-III/10462-67 dated 25-09-2014 **without publishing transfer order on the website.**

5. Website <http://health.delhigovt.nic.in/mis/frmlogin.aspx> of H & FW Deptt is self explanatory that **transfers are done through stand relieve orders and declared canceled on the same day or next day or after few days due to the reasons well known to Sh. S.C.L. Das.** Uncounted cases can be seen on Delhi Govt Website regarding cancellation of Transfer Orders. **If there was no need of transfer of doctor then why he transferred and then why again canceled the transfer immediately?**

LEADING OBJECTIONABLE QUESTIONS

1. Why transfer orders are not published on the website?
2. How these transfer order stands valid done without publishing on MIS website?
3. Why backdoor transfer orders were passed and enforced?
4. Under which rule of transfer policy, he ordered transfers of newly recruited doctors?
5. What was the public interest or administrative issue involved in these bulk transfers of newly recruited doctors?

EFFECT OF MY COMPLAINT ON H & FW DEPTT

Just after disclosure of corruption in Transfers of Doctors on 08-12-2014, Sh. S.C.L. Das has started Manipulation and Fabrication of transfer records and proved himself that he has misused his power in transfer postings of doctors through violation of own Rules/Regulations/Transfer policy. H & FW Deptt become active, forged documents are prepared and uploaded on website in back dates to hide their corrupt activity. Major manipulation and fabrication done after getting complaint.

Earlier, objections were raised against two transfer orders BUT manipulation of H & FW Deptt has itself disclosed more TRANSFER SCAMS which are as follows:

CASE NO.-1

Reference Transfer order no.F.70/57/03/H&FW/PF-III/10462-67 dated 25-09-2014 of Dr. Sone Lal and Dr. Asit Kumar Baweja (Attached annexure – Annex_Case1.pdf)

- Manual transfer order issued on 25-09-2014 (on a single page) - Dr. Sone Lal transferred from AAAGH to DHAS and Dr. Asitesh Singh Bajwa transferred from DHAS to AAAGH with immediate effect.
- Manipulation and Fabrication done on website as - 2 different orders issued; First for Dr. Asitesh Singh Bajwa, stand relieved w.e.f. 25-09-2014. Second for Dr. SoneLal, stand relieved w.e.f. 04-10-2014. These 2 orders showing publish date as 25-09-2014 On the website.
- Web page (Circular/Order/Letter) print out dated 03-11-2014 clearly showing that these transfer orders no.F.70/57/03/H&FW/PF-III/10462-67 dated 25-09-2014 **were uploaded on the website (MIS) after 03-11-2014 in back dates.**
- **OBJECTIONS:** Why **invalid** manual transfer order was issued on 25-09-2014? Why order uploaded on the website after passing more than one month in back date? Why bifurcated transfer issued with different relieving dates? Which transfer order should be consider as valid, Manual OR MIS generated orders, which are having different modes of relieving?

CASE NO-2

Reference Transfer order no. F.70/43/2014/H&FW/part-file/12356-80 dated 07-11-2014 of 19 doctors, posted in Delhi Govt. in September 2014. (Attached annexure – Annex_Case2.pdf)

- Manual transfer order no. F.70/43/2014/H&FW/part-file/12356-80 issued on dated **07-11-2014** with immediate relieving of **19 doctors**.
- Forged document of transfer prepared and uploaded on website with same transfer order no. F.70/43/2014/H&FW/part-file/12356-80 showing issue date **07-11-2014** of **only 13 Doctors** with stand relieve order **w.e.f. 07-11-2014**.
 - **What is the controversy?** This above said order clearly directing towards fraud because almost all doctors are still working in same hospitals where they are posted and not relieved by Medical Superintendents. If Web based stand relieve order is correct then **EITHER** Doctors kicked out the transfer order of Pr. Secy Health and not relieved on 07-11-2014 **OR** Fabricated document uploaded on the website in back dates through manipulation and deceived the doctors so that they still working in same hospitals. **PLEASE DECIDE WHAT IS THE TRUTH?**
 - **Why it is called Manipulation and Fabrication? TWO different transfer orders were passed which had ONE order no. F.70/43/2014/H&FW/part-file/12356-80 dated 07-11-2014. First manual transfer order had 19 doctors and Second Web based transfer order have name of 13 doctors? Why 6 doctors were dropped in web based transfer list?**
 - **FAVORITISM, MISUSE OF POWER AND CORRUPTION IS DEEPLY INVOLVED IN CASES OF TRANSFER OF DOCTORS.**

Manipulations and fabrications in **Web page (Circular/Order/Letter) done through inclusion of transfer orders in back dates after my complaint (Attached annexure – Annex_Case3.pdf)**

- Transfer order No. f.70/43/2014/H&FW/2014/PT.FILE/12529-39 dated 12-11-2014 of Dr. Rahul Rajput. (**Annex_Case3.pdf Page 1**)
- Transfer order No. F.70/43/2014/H&FW/2014/PT.FILE/12356-80 dated 07-11-2014 of 13 doctors to different hospitals. (**Annex_Case3.pdf Page 2**)
- Transfer order No. 2(4)/2013/DHS/Estt/HQ/59939-949 dated 05-11-2014 of Dr. D.R. Gupta with relieving 05-11-2014 (FN). Is it practically possible that Health deptt has published the order on website 05-11-2014, Dr. D.R. Gupta received the order before 12 Noon on 05-11-2014 and joined his duty as CDMO North East before 12 Noon on 05-11-2014? This super fast transfer must have some very very urgent or emergency cause . What was the reason for this super fast transfer order? (**Annex_Case3.pdf Page 3**)

4. Manipulations and fabrications resulted into **few FUNNY ORDERS** and definitely raising many questions on the transfer orders, as follows: (**Attached annexure – Annex_Case4.pdf**)

- Transfer order file no. 1/01/2014/DHS/ESTT/HQ/60551-57 **dated 10-11-2014** OF Mr. shahida Parveen showing stand relieve order w.e.f. **15-09-2014** (FN). (**Annex_Case4.pdf Page 1**)
- Transfer order file no. 1/01/2014/DHS/ESTT/HQ/60551-57 **dated 10-11-2014** of Dr. Ahmad Nadeem showing stand relieve order w.e.f. **03-09-2014** (FN). (**Annex_Case4.pdf Page 2**)
- Another Transfer order file no. 1/01/2014/DHS/ESTT/HQ **dated 10-11-2014** having name of 4 doctors i.e.Mr. Vijay Puniya, Mr. Shahida Parveen, Dr. Ahmad Nadeem and Dr. Binny

Dua showing stand relieve order w.e.f. **15-09-2014** (FN). (**Annex_Case4.pdf Page 3**)

- Another Transfer order file no. 1/01/2014/DHS/ESTT/HQ dated 10-11-2014 having name of all 4 doctors i.e.Mr. Vijay Puniya, Mr. Shahida Parveen, Dr. Ahmad Nadeem and Dr. Binny Dua showing TRANSFER CANCELLATION ORDER. (**Annex_Case4.pdf Page 4**)
- H & FW Deptt transferred Dr. Razi Akhtar, **stand relieved w.e.f. 15-09-2014 (AN)** through File no. 1/01/2014/DHS/ESTT/HQ/60645-51 **dated 10-11-2014. How doctor can be relieved from back date?** (**Annex_Case4.pdf Page 5**)
- **WHAT IS FUN AND CONTROVERSY IN THIS CASE?** Transfer order of Mr. Shahida Parveen issued on 10-11-2014 with stand relieve on 15-09-2014. How it can be possible? Transfer order of Dr. Ahmad Nadeem issued on 10-11-2014 with stand relieve on 03-09-2014. Again **How it can be possible to relieve in back date?** On the same day 10-11-2014, transfer order issued in favor of 4 doctors with stand relieve on 15-09-2014, against relieving from back date and included 2 new doctors. Finally transfer order dated 10-11-2014 showing cancellation of transfer orders.

Why transfer was required in this case and why transfer order canceled? DUE TO these type of controversial transfer orders, it is not clear that which doctor really transferred? Is it not a case of Manipulation and Fabrications of records?

CASE-5

H & FW Deptt has given fresh posting to newly recruited 37 Specialist doctors from UPSC on dated 25-07-2014. Sh. S.C.L. Das has transferred 5 doctors to another hospital after 5 days on 01-08-2014 without publishing on website through transfer order no. F11/75/H&FW/2014/6064-74. This was MANUAL TRANSFER ORDER. As per order of Pr. Secy Health Sh. S.C.L. Das dated 20-05-2014, these transfers must be declared **INVALID** but it is approved with the blessings of corruption. (**Attached annexure – Annex_Case5.pdf Page 1 to 3**)

- I have not highlighted this transfer order earlier in complaint dated 08-12-2014 and therefore it is not manipulated by H & FW Deptt. **NOW LETS SEE, WHETHER H&FW DEPTT WILL MANIPULATE IT OR NOT AFTER GETTING THIS COMPLAINT?** (**Annex_Case5.pdf Page 1**)

Therefore, it can be easily said the allegations made in previous letter dated 08-12-2014 are true and a big racket of corruption is going on in H & FW Deptt under cover of Sh S.C.L. Das. Other allegations made against Sh. S.C.L. Das are as follows:

1. Harassment of Whistle Blower (Dr. Avinash Kumar) done by Sh S.C.L. Das through transferring him to Babu Jagjivan Ram Memorial Hospital, Jahangirpuri, Delhi especially when MODEL CODE OF CONDUCT WAS ENFORCED IN DELHI as he comes to know about raising voice against corruption.
2. Sh. S.C.L. Das already punished Dr. Avinash Kumar, Whistle Blower under CCS Conduct Rule 16 and **after imposing punishment inquiry is ordered.**
3. Sh. S.C.L. Das is providing full protection to corrupt doctors of Aruna Asaf Ali Govt. Hospital, 5-Rajpur Road, Delhi-54. **NO ACTION initiated against any corrupt doctors till date** being competent authority even getting all the documentary evidences against corruption, proved in enquiry and when 2 FIRs are registered and more are pending.
4. Chief Secretary of Delhi has ordered for Disciplinary proceedings in ACB and to file chargesheet against the corrupt doctors of AAAGH but Sh S.C.L. Das has not initiated any disciplinary proceedings against delinquent doctors. **Full protection still providing to corrupt doctors of AAAGH.**
5. Latter on, Sh. S.C.L. Das constituted a 4 member committee out of which 3 members were junior to the alleged doctors to inquire the same case in which CHIEF SECRETARY ORDERED FOR D/P against alleged doctors. He constituted the committee to protect the corrupt doctors of AAAGH and bypassed the order of Chief Secretary.
6. Misuse of Power by Sh. S.C.L. Das, Pr. Secy. Health, Govt of NCT of Delhi in Transfer Postings of Doctors was provided through complaint dated 08-12-2014.
7. Now shown the Manipulation and Fabrication of Transfer Records of Doctors done by Sh. S.C.L. Das, Pr. secy. health, Govt of NCT of Delhi after complaint.

No concrete action taken against any Delinquent officer since exposure of corruption to Central Vigilance Commission (CVC) dated 01-08-2013 as Whistle Blower. Therefore, I humbly request you sir to please take necessary action against Delinquent officers involved in deeply rooted corruption of H & FW Deptt, Govt. of NCT of Delhi. I eagerly waiting for your kind reply.

DECLARATION

Though, I have exposed multiple cases of corruption against many powerful authorities & persons which becomes a big threat for me & my family. Therefore, I hereby declare that in case of any injury or any mishap occurs at any time or day on myself or to any member of my

family, the whole responsibility shall be on Sh. S.C.L. Das, Pr. Secy. Health, GNCT of Delhi, Dr. Surendra Singh, Dr. Ashok Jaiswal, Dr. S.B. Srivastava, Dr. Amit Sharma and suppliers of those firms against whom I exposed their involvement in corruption.
