I am assuming that all MS are aware of stock of medicines which is available in their hospitals. Also, all MS are aware of the demand their hospitals have raised on Nirantar over the past months. Such demand had triggered purchases which are lying unclaimed at the warehouses.

Please certify that all items relating to demands raised earlier have been shifted by the hospitals from the warehouses to their hospitals. This is the responsibility of respective hospital. This has apparently not been done by some MSs.

I am expecting a clear certificate from all MS by end of day today that all their past demands have been lifted from the warehouse.

Subject: Supply orders against Apr Demand

All facilities are aware that supply order is triggered on the first Monday of every month against demand submitted at Nirantar, for CPA RC items. Thus for demand submitted at "Aug16-Med" link, it should have been issued yesterday.

But this did not happen.

There are medicines in our ware houses which need to be rotated, lest these would expire. We had requested the stores to submit their monthly demand considering the stock position at the warehouses. Stock position is available at Nirantar. But this was not taken note of.

A method shall have to be devised to deal with it in a couple of days; then only orders shall be triggered. Alternatively, we may ask stores to resubmit demand after fresh assessment.
