Sub: Lodging of complaint against unknown person(s) who have forged the documents and cheated the hospital in case of purchase and installation of Token Display system and Electronic Page Board. Sir, Apropos to the above cited subject,instance of cheating and forgery were found in the purchase and installation of token display system and electronic page board that were purchased and installed through an open tender system(e-tender) in the year 2008. It was observed by the Div. Commissioner during a surprise visit on 22.07.2014 and reiterated in another surprise inspection by Spl. Secy. To Lt. Governor on 20.08.2014 that the electronic token system should be made functional. During the subsequent steps taken by the hospital to make the token system functional,the firm M/s Rohit Signads Pvt. Ltd.,that had installed the system in 2008 was contacted to inspect and repair the token display system. However the firm M/s Rohit Signads in their subsequent e-mails to the hospital,categorically refused to have installed any token display system in Aruna Asaf Ali Govt. Hospital. As per the records available in the hospital,an amount of Rs. 11,95,258/-(Rs. Eleven Lakh Ninety Five Thousand Two Hundred and Fity Eight only) was paid to M/s Rohit Signads Pvt. Ltd. For installation of token display system(41 no.s) and electronic page boards(02 no.s) on 31.01.2008. The firm M/s Rohit signads Pvt. Ltd. has in their e-mail replies categorically denied having received any payment from the hospital. They have again stated that the firm has not done any work in Aruna Asaf Ali Govt. Hospital. In view of the above facts,it is clear that the hospital has been cheated for the amount of Rs. 11,95,258/-(Rs. Eleven Lakh Ninety Five Thousand Two Hundred and Fity Eight only) by unknown person(s). therefore, you are requested to register a complaint of Cheating,Forgery and Fraud/Theft of Government Money.
