Following direction of the Hon'ble Health Minister to keep a reserve of medicines and consumables in warehouses, CPA had ordered approx. 3-month of average ordered during preceding 4 quarters for some items at ware houses. These items do not include bulky items like IV fluids. This endeavour further got restricted by less than optimal availability of space etc.

These items are not specific to demand of any facility. But the facilities are expected to indent it to enable the stock to be rotated. The request has thus been made to lift items.

The Nirantar is being modified now to show the availability of such stock to all pharmacists while they are placing monthly indent.
