3. PIO, Office of CS denied information as does not pertain and information not available against Q.No. 1 to 8.
4. PIO, H & FW Deptt denied information against Q.No. 1 to 5 under provision of 8(1)(h) of the RTI Act 2005 and replied that Q.No. 6 to 8 not pertain to Vigilance branch of H&FW.
5. PIO, AAAGH stated that "as per direction, a complaint was filed in ACB vide letter No. F.7(235)/Misc. Complaint/AAAGH/2013/Pt.file/3606-08 dated 22-07-14 and for DP against delinquent officer draft charge sheet along with authenticated copies of relevant documents of and biodata of SPS was sent to Dy.
