MEETING NOTICE

This directorate, vide its letter of even number dated 31-08-2015, made some observations and requested to H&FW dept to re-examine the matter for initiation of disciplinary proceedings against doctors of Aruna Asaf Ali Govt Hospital in the matter of discrepancies in the purchase of X-ray automatic chemical developer and X-ray automatic chemical fixer and provide a proposal for initiation of disciplinary proceedings against doctors of Aruna Asaf Ali Govt Hospital with specific recommendation of the department, along with draft charge sheet and authenticated copies of relevant documents. However, the same is still awaited despite reminders dated 01-01-2016, 02-05-2016 & 10-05-2016, wherein it was clearly stated that one of the SPS i.e. Dr S B Srivastva is going to retire on superannuation from Govt.
