The complaints were examined on case to case basis in the form of eleven (11) cases. The report of these cases is placed in eleven files including the complaints, inclusive report of the committee and statements of Dr. Surender Singh and Dr. S.B. Srivastava.

Meanwhile, another letter dated 07.07.2014 regarding more allegations of corruption has also been received in this hospital from the office of the Secretary, Health & Family Welfare Department, GNCT of Delhi. This is also enclosed.

The hospital administration has already submitted the report of the inquiry committee to the Secretary, Health & Family Welfare, GNCT of Delhi. The copy of the same report in eleven files is hereby forwarded to your department for taking further necessary action as per the directions of the Chief Secretary/ Chief Vigilance Officer, GNCT of Delhi.
