Subject: Harassment by the competent authorities of Health & Family Welfare department of Govt of NCT of Delhi for being a Whistle blower

Respected Sir,

I have filed a complaint to CVC under subject - Corruption of Aruna Asaf Ali Govt Hospital, 5-Rajpur Road, Delhi-54 under "Public Interest Disclosure & Protection of Information Resolution" through a letter dated 01-08-2013.

I further submitted my confirmation on dated 28-08-2013 against your letter no. Conf/CFM/1192/13-222549 DATED 13-08-2013 and also provided the details about disclosure of my Identity by the Medical Superintendent, Dr. Ashok Jaiswal, Aruna Asaf Ali Govt. Hospital to Dr. Surendra Singh, Dr. Amit Sharma who are the main culprits of corruption and other doctors of the hospital also.

Afterward, all the above mentioned doctors including the Medical Superintendent had started negative canvassing against me to higher authorities of Health & Family Welfare department in Delhi Secretariat.

The result of negative canvassing brought in form of my transfer from this hospital to Babu Jagjiwan Ram Memorial Hospital, Jahangirpuri, Delhi through letter dated 28-11-2013 which uploaded on Delhi govt website on 02-12-2013 with stand relieved order w.e.f. 03-12-2013 (A/N). This transfer is done by the competent authorities when the code of conduct is applicable in Delhi in view of forthcoming elections on 04-12-2013.

This nexus of doctors are wishing my transfer because they are totally handicapped in fear to use any unethical corrupt practice for milking money from this hospital. They are not getting success to influence the committee of the hospital who are investigating various complaints of corruption due to fear of my vigilant eye. The present M.S. of the hospital, Dr. Ashok Jaiswal was the then D.M.S of the hospital and he is also involved in the said corruption

and there is less chance of fair inquiry in these cases. Therefore, it become very important for them to transfer me from this hospital, so that they can manage all the allegations and adverse situations easily in favor of them.

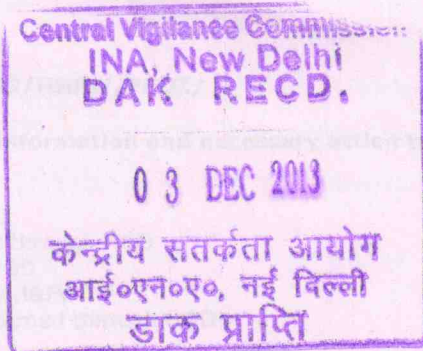
Sir, I am not against my transfer but my transfer was done in a biased manner and I feel that the higher authorities are protecting these corrupt doctors instead of doing fair inquiry and punishing them. **They are punishing the Whistle blower who has unearthed the corruption of Aruna Asaf Ali Govt. Hospital and trying to prevent further corruption.** The authorities must do the transfer of these corrupt doctors because they may not influence the inquiry committee but they have done the transfer of whistle blower, who raised the voice against these corrupt doctors.

Therefore, I request to you sir, please look into the matter sympathetically and please withheld my transfer till the inquiry is completed and the corrupt doctors get transferred from this hospital.
