Subject: Complaint against Sh. S.C.L. Das, IAS and other

Respected Sir,

In reference to your letter no F.No. 14036/23/2013.UTS-I dated 22-09-2014 along with the enclosure of complaint regarding above cited subject, **I hereby declare that the enclosed complaint is written by me and request you for further necessary action.**

I assure you that I have the documents to establish my allegations. In brief, the grievances are as follows:

**(A) DISCLOSURE OF MY IDENTITY OF WHISTLE BLOWER**

My identity of Whistle Blower was disclosed through two routes, which are as follows:

**First Route:**

1. Identity of Whistle Blower (Complaint filed under PIDPI Resolution) disclosed by CVC itself by without hiding my name, address, mobile no. and E-Mail.
2. CVC forwarded my complaint to Mr. Arvind Ray, Pr. Secretary Vigilance, Govt of NCT of Delhi, here again identity was disclosed.
3. Mr. Arvind Ray, Secretary Vigilance, Govt of NCT of Delhi, forwarded the same complaint to Mr. S.C.L. Das, Pr. Secy. Health, Govt of NCT of Delhi, here again identity was disclosed.
4. Mr. S.C.L. Das, Pr. Secy. Health, Govt of NCT of Delhi, forwarded the same complaint to Dr. Ashok Jaiswal, Medical Superintendent, Aruna Asaf Ali Govt. Hospital against whom and other doctor of this hospital, the complaint was filed.

**Second Route:**

1. The confirmation confidential letter (as you are confirming about the complainant) sent from CVC was deliberately opened by Dr. Ashok Jaiswal and 2 nd letter for sending the complaint no. from CVC was also opened by Dr. Ashok Jaiswal, endorsed the letters and disclosed my identity.

**(B) VICTAMIZATION OF WHISTLE BLOWER**

1. I was transferred to another hospital especially when Model Code of conduct was enforced in

Delhi in view of assembly elections in Dec 2013 and also far from my residence without having any transfer policy in H & FW Deptt. as soon as my status came in the knowledge of competent authorities.

2. In another case, Mr. S.C.L. Das, Pr. Secy. Health ordered Dr. Ashok Jaiswal, M.S., AAAGH, to divest me from the post of Purchase officer and exclusively issued show cause notice. Not ordered to divest purchase committee, Medical Superintendent being competent authority.
3. Written warning issued (Rule 16) and directed to place the copy in ACR Dossier **without inquiry** through order dated 30-05-14. Here he has not issued this direction in favor of Dr. Ashok Jaiswal being competent authority.
4. Afterward, Mr. S.C.L. Das, Pr. Secy. Health **forwarded the name of Dr. Avinash Kumar to take action under Rule 14 to Hon'ble Lt. Governor** which he turned down and ordered to take action under Rule 16 against all the officers involved in this case.
5. Now, Mr. S.C.L. Das, Pr. Secy. Health ordered M.S. AAAGH to file charge sheet against all the officers involved in this case.
6. **No inquiry conducted in this case. No opportunity given to be heard before imposing punishment and filing charge sheet after imposing penalty is beyond to understand.**

#### **(C) FAVORING CORRUPTION AND CORRUPT DOCTORS**

1. Mr. S.C.L. has not issued even a single memo to any one of the alleged doctors involved in several cases of corruption.
2. Only 2 doctors were transferred only due to intervention of Hon'ble Lt. Governor and even then he saved one doctor from transfer.
3. Transferred the alleged doctors to big hospitals?

**NOTE:** I'm doctor by profession, learned Medical books and experienced in Medical field. I'm not a clerk, not having any administrative degree and not learned administration BUT in public interest and help the government to combat the shortage of staff, we doctors help the administration by taking multiple administrative charges and try to help the administration apart from daily routine patient care work.

Mr. S.C.L. DAS has created it a big issue especially in such a case **where no expenditure incurred till date. It is prejudice act to victimize a whistle blower.** This type of attitude of Pr. Sec. Health in case of Photocopier machine definitely demoralizing the doctors and conveyed the message that the doctors should not help in administration. They have to work only in their field. If agreed, Mr.



S.C.L. Das, Pr. Secretary Health must issue an order to "withdraw all the administrative charges from the doctors and the doctors should completely concentrate on their main experienced Medical field".  
**I'm sure, if it happens, the Health Care System in hospitals will definitely improve by several folds.**

I'm harassed and victimized by Mr. S.C.L. Das in administrative matter which is not my field. If disagreed with my statement, I challenge Mr. S.C.L. Das being Pr. Secretary Health who learned the administration but handling the Health department, he must sit in a hospital and treat the patients. Can he treat the patients in hospital perfectly? Can he treat serious ICU Patients? When we doctors can do administration work along with Medical work then why Mr. S.C.L. Das can not do Medical work along with Administrative work without any mistake? Before that he must have a valid Medical degree. Likewise, Why he don't appoint the administrative degree holders in hospitals to perform administrative works?


