Dear Sir,

I, H N Basavraj, s/o Late Sri H Neelakantappa, aged 62 years, Managing Director, PSK Pharma Private limited, 121/22 Mahajenahalli, Shimoga Road, Harihar-577601, Mobile No.: 99861 48198, wish to bring to your kind notice the following facts:

I am engaged in the manufacture of surgical disinfectants and antiseptics at the above mentioned address and my products are supplied all over India and exported too.

I despatched 116 Cans of our product **Fumifloor** 5 Litre vide Invoice No. 97 dated 22.08.2007, and 584 Nos. of the same product vide Invoice No. 116 dated 31.08.2007 to M/s Shashi Medical Services, B-4, Rakesh Deep Building 11, Yusuf Sarai Commercial Complex, Gulmohar Enclave, New Delhi-49, Phone No. 26568728, the owners of which, to the best of my knowledge, are Mr. Nitin Singhal and Mr. Daksh Kulbe. The above consignments were despatched through Associated Road Carriers Limited vide LR No. 248103 and 248138 respectively. Subsequently, there was no sale of our Fumifloor to the said party till date.

I received an email from Dr. S K Sharma, Medical Superintendent, Aruna Asaf Ali Government Hospital, Delhi on 09.08.2014, requesting for analysis reports of **Fumifloor** 5 Litre pack with Batch No. 09020182 and 09014210, along with an attachment of the photographs of the said product with the said Batch Numbers. Looking at the pictures of the labels, and the batch Numbers therein, it was evident that the said cans were not manufactured by me at all. I sent my prompt reply to Dr. S K Sharma to this effect.


On 10.09.2014, I received a copy of the Hindustan Times (Delhi), which carried an article about the management of Aruna Asaf Ali Government Hospital lodging a complaint with the Anti-Corruption Bureau (ACB), Delhi in connection with irregularities that have occurred in their hospital supplies. It was also reported in the article that M/s Shashi Medical Services Delhi have supplied 1,250 Nos. cans of **Fumifloor** 5 Litre during 2010-11, which are spurious. Since I have not supplied Fumifloor 5 Litre after the initial supply of 700 cans in 2007, it is evident that Mr. Nitin Singhal and Mr. Daksh Kulbe have managed to supply spurious product using my brand name and fake company labels, and thereby cheating me and the hospital.

Further, I have been informed by Dr. S K Sharma, Medical Superintendent, Aruna Asaf Ali Government Hospital, New Delhi, that the Government of NCT of Delhi, Office of the Medical Superintendent, Aruna Asaf Ali Government Hospital, Delhi-110054 have already lodged a complaint with the Deputy Commissioner of Police (North) on 11.08.2014 in this connection.

Further, today, I have filed an FIR at Harihar Rural Police Station in this connection and a copy of the said FIR is enclosed herewith for your kind reference.

This is for your kind information with a request to kindly take action against the culprits.
